**Subject: Letter Opposing the Re-registration of Paraquat**

**The undersigned 56 farmworker, public health, environmental justice, environmental, human rights, faith-based and farmer advocates urge the EPA to ban paraquat because of its substantial and demonstrated risks to environmental and human health.** The EPA must cancel registration of this pesticide in order to adequately protect the people and places most likely to be harmed by this dangerous herbicide.

Paraquat is the most acutely lethal herbicide still in use in the United States today and has resulted in the death of at least 30 people country-wide in the last 30 years. In addition, chronic paraquat exposure has been associated with an increased risk of developing Parkinson's disease and it is a suspected endocrine disrupting chemical.

Much of the world has banned or is in the process of phasing out paraquat due to its high toxicity, including three of the largest agricultural producing economies in the world – the European Union, China and Brazil.

Yet paraquat use in the United States is higher now than it's been in the past 25 years, with use rising considerably in recent years. This increase shows no signs of slowing.

Despite its extreme toxicity, the EPA has only proposed weak restrictions on future use of paraquat. For instance, the agency has proposed prohibiting aerial applications of paraquat, but includes an exemption for the most common aerial use: cotton desiccation. Considering that only 3% of paraquat applications are made aerially and the most common aerial use is exempted, this will do little, if anything, to reduce the harm from this pesticide.

While the long overdue prohibition on use of paraquat by backpack sprayer and handgun application will eliminate some high level exposures, overall EPA has exacerbated the problem by reducing the Food Quality Protection Act (FQPA) Safety Factor by 3-fold, essentially erasing protections for the most vulnerable young children in our population. The agency has also ignored strong associations with Parkinson's disease.

The agency found serious risks to farmworkers who are exposed to high levels of paraquat on the job, which also poses a significant risk to their families via residues that are transported from the job site to the home. The agency proposes to address this problem by requiring additional Personal Protective Equipment (PPE) for workers, some of whom labor in 100-degree summer heat. This is not reasonably achievable, nor is it reasonable to assume that these requirements that look good on paper will be faithfully adopted in the real world.

The EPA has also identified considerable environmental harms, including to mammals, birds and pollinators that forage near treated fields, that are not mitigated whatsoever in the proposed decision.

We urge the EPA to immediately ban paraquat. Farmworkers, farmers, children, and natural places in the US should no longer be harmed by this chemical that has already been banned in so many countries around the world. The proposed re-registration of paraquat represents a blatant failure to protect public health and the environment.
